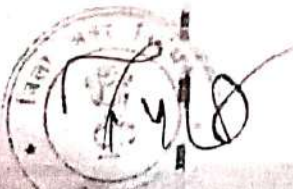

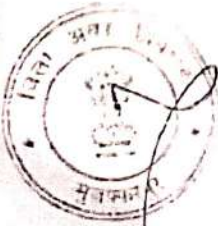
**2. That the objects for which this trust is established are:**

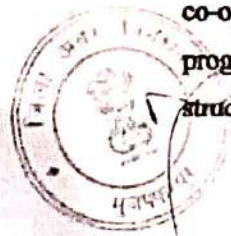

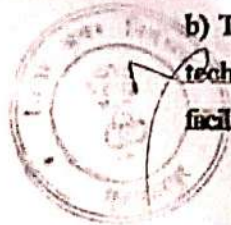

- c) To promote research development and adaptation of science and technology for improving quality of life of traditional artisans, landless labor and poor section of the Society.

x. → In the field of other programmes: -

- (i) To accept loan, Grant-in-aid, donation (either in cash or kind), subsidy or other assistance lawfully, either from National and/ or International agencies for the attainment of the objective of the Trust.

3. All the activities shall be Non Profitable and shall be done on 'No Profit-No Loss' basis.
4. All the incomes, earnings, movable/immovable properties of the trust shall be solely utilized and applied towards the promotion of its Aims and Objects only as set forth in the deed of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past member of the trust or to any person claiming through any one or more of the present or the past members. No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of his membership.
5. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contribution from time to time
6. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.
7. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the trust.
8. Subject to the Provisions of Income Tax Act, 1961 as amended from time to time, the Trustees will keep the Trust fund or such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or construction of any immovable property including buildings and/or in the purchase and acquisition or mortgage by way of fresh charge on any immovable property in India, of free-hold or lease-hold tenure, and may deposit the amounts with any scheduled Bank, Company or Private firm or Individual on such terms and conditions as they think fit, In the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply; in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. 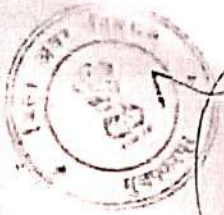

- (xiv) To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- (xv) To take over or amalgamate with any other charitable trust, trustee, association, or institution with similar objects.
- (xvi) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- (xvii) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
10. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
11. The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

12. The managing Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.
13. A person shall cease to be a Trustee either:
  - If he without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year, whichever is longer, or
  - If he is requested to resign by 3/4<sup>th</sup> or as near thereto as possible of the remaining trustees.
14. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
 

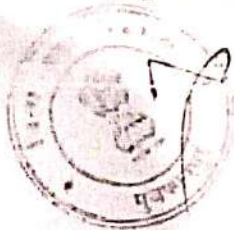
The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:

  - (a) Five Trustees shall form a quorum for a meeting of the Trustees.
  - (b) All matters will be decided mutually by the Trustee.
  - (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
15. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
16. The accounting year of the Trust shall be the financial year ending on 31<sup>ST</sup> March every year.
17. The Trust and the Trust funds shall be irrevocable for all the times.
18. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.
19. Two-thirds majority shall situate the office of the Trust at Muzaffarpur unless changed by the Trustees.

**20. POWER & FUNCTION OF THE OFFICE BEARER**

**PRESIDENT:**

The President shall preside at all meetings of the Managing Trustee and of the trustee when he is present and shall exercise such other powers as are conferred upon him by these rules. The President may call for an emergency meeting through President Signed notice in a shorter notice. The decision of President that a resolution has been

carried or lost shall be conclusive, unless such a decision is challenged and a poll is demanded; on poll being demanded, the same shall be taken in such manner as the President may in discretion determine. In case of a tie the President shall have a second or casting vote.

- a) He shall be in charge of the office and shall be responsible to general body in all matters. He will contract in all ways and means of the position of the association and shall have right to improve it.
- b) He shall be convener of all the meetings and without his signature on the notice of meetings no meetings will be valid.
- c) It shall be his duty to see that the resolution at the respective meeting are implemented and give to effect to timely.
- d) He shall be at liberty to spend for the purpose of the trustee without sanction of the Managing Trustee to do all such other lawful notes, deeds of things as incidental or conducive to the attachment of trustee.
- e) Settler cum Managing Trustee and his legal depended shall be permanent holder of presidentship.

**SECRETARY:**

- a) He shall produce the accounts of the trustee before Managing Trustee for approval.
- b) He will produce the expenditure of the trustee before the Managing Trustee for approval.
- c) He shall appoint, suspend, discharge, fix the salary, make payment of the employees of the institution and conducted by the trustee on behalf of the Managing Trustee.
- d) He shall maintain the account in proper and prescribed form. He shall deposit and withdraw the amount of the trustee in the bank or in the post office with the signatures of his own and also with counter joint signed by the Treasure or President.
- e) In the absence of President, the trustee will look after all powers conferred on Secretary.

**TREASURER:**

- a) The treasurer will act under the direction of the committee.
- b) Any amount exceeding Rs. 10 000/- which is not required for immediate use shall be paid into such bank or banks as may be approved or by the committee. The treasurer shall ordinarily receive all payments and disburse the amount passed by the President and shall maintain proper books of accounts.

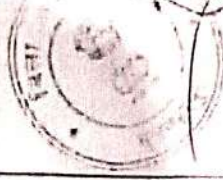
